ACTION PLAN FOR THE IMPLEMENTATION OF THE MIGRATION MANAGEMENT STRATEGY for period from 2011 - 2012

I. INTRODUCTION

Migration Management Strategy (*Official Gazette*/ no. 59/09), constitutes the first step towards establishing a migration management system in the Republic of Serbia. The starting point for the development of the Action plan for the implementation of the Migration Management Strategy was the Strategy's main task, namely introducing coordination within the migration management system in the Republic of Serbia and laying the foundations for the mechanism to manage migration in a comprehensive manner, in line with the European migration flows management policy, while taking due account of local specific features.

Action plan for implementation of the Migration Management Strategy for period from 2011 to 2012 (hereinafter: Action Plan) defines the set of specific activities to be carried out in the period of 2011–2012, whereby the Strategy objectives should be achieved. It consists of narrative part and table.

Narrative part of Action Plan is divided into following chapters: I. Introduction; II. Action Plan Objective; III. Monitoring of implementation of Action Plan and IV. Financial means.

Table section of the Action Plan contains the following columns:

- 1) Activities whereby measures for the achievement of strategic and specific objectives defined in the Migration Management Strategy are put into practice;
- 2) Implementing parties;
- 3) Partners to implementing parties;
- 4) expected results;
- 5) Indicators for monitoring the realization of planned activities;

- 6) Timeframe for completion of activities;
- 7) financial means required for implementation of activities and sources of funding.

The Action Plan has been developed on the basis of action plans of competent authorities tasked with carrying out specific activities foreseen in the Migration Management Strategy, as well on the experience, knowledge and needs identified in the period since the adoption of Migration Management Strategy.

The National Programme for Integration of the Republic of Serbia into the European Union states, in the section on migration management, that the Republic of Serbia is committed to being a part of European policy and strategy for managing migration flows. This Action Plan sets a framework for building a migration management system that could be a part of the European migration network in strategic and operational terms and a tool for implementing EU migration policies. In drafting this Action Plan, significant support has been provided to the Commissariat for Refugees by the Delegation of the European Union to Serbia through the mission Support to the Commissariat for Refugees in capacity building for migration management

II. ACTION PLAN OBJECTIVE

The objective of the Action Plan is to implement of the Migration Management Strategy, through fulfilling its objectives by carrying out the proposed activities

The overarching aim foreseen by the Migration Management Strategy is to manage migration in a comprehensive manner, which will support the fulfilment of sector-specific objectives and state priorities in the field of migration.

In view of the broad nature of the subject matter, the Migration Management Strategy also foresees three strategic objectives, further elaborated through specific objectives, namely:

1) Establishing and implementing mechanisms for a comprehensive and consistent monitoring of migration flows in the Republic of Serbia

- 2) Integrating the strategic, legal and institutional framework for the joint management of migration
- 3) Protection of the rights of migrants, the creation of conditions for the integration and social inclusion by raising awareness about the importance of migration

Strategic objective 1 will be realized by fulfilling the following specific objectives:

- Institutionalizing the jurisdiction over the collection and analysis of the data on the extent and flows of migration
- Defining the migration profile of the Republic of Serbia and updating it regularly

Strategic objective 2 will be realized by fulfilling the following specific objectives

- Strengthening of the capacity of the Coordinating Body for Monitoring and Management of Migration and to make its work more effective and efficient
- Ensuring the implementation of clear policies in the field of migration management;
- Encompass normative prerequisites for a comprehensive and effective migration management harmonized with EU standards

Strategic objective 3 will be realized by fulfilling the following specific objectives:

- Familiarizing the public with the problems of migrants
- Sensitizing the bodies of the state administration and local governments that are responsible for the realization of the rights of migrants

III. MONITORING OF IMPLEMENTATION OF ACTION PLAN

Monitoring of implementation of Action Plan will be carried out through indicators set in the Plan. Monitoring of implementation of the Action Plan will be monitored with purpose of identifying progress in realization of envisaged activities, increasing of its efficiency and rational use of resources.

IV. FINANCIAL MEANS

For carrying out of Action Plan there are no special means allocated in the Budget of Republic of Serbia for 2011, as the majority of activities do not require engagement of additional civil servants and represent regular activities which ministries and special organizations do within their scope. In addition, a project, financed from EU pre-accession funds, that aims to strengthen the capacities of institutions dealing with migration is implementing precisely those activities foreseen by the Action Plan. A few activities, expected to commence in 2012 when organisational technical capacities are provided, will be included in the next year's budget by ministries and special organisations. The possibility of covering the costs not foreseen as part of ministries' and special organisations' ongoing costs by grants from international organisations will be taken in account.
